A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT FOR A LOAN UNDER THE KANSAS WATER POLLUTION CONTROL REVOLVING FUND ACT (K.S.A. 1988 SUPP. 65-3321 THROUGH 65-3329).

WHEREAS, under the terms of the Kansas Water Pollution Control Revolving Act (K.S.A. 1988 Supp. 65-3321 through 65-3329), the State of Kansas has authorized the making of loans to authorize applicants to aid in the construction of specific public projects.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF SOUTH HUTCHINSON, KANSAS, AS FOLLOWS:

Section 1. Loan Application. Section 3. Further Authority. This Resolution shall be in full force and effect from and after its adoption.

This Supplemental Agreement between the Client and Professional Engineering Consultants, P.A. (PEC), modifies the above referenced Agreement, and any other previous Supplemental Agreements as may be noted herein.

A. Modification of Scope:

- 1. Project Description shall be modified to include the following: Demolition of the existing belt filter press and polymer feed system and replacement with a new unit and feed system as outlined in the Pre-Design Technical Memorandum.
- 2. Civil Design Services shall be modified to include:
 - a. Develop demolition plan for removal of existing belt filter press and polymer feed.
 - b. Develop plans and specifications for installation of new belt filter press and polymer feed for piping connections, valves, appurtenances, and instrumentation.
- 3. Structural Design Services shall be modified to include:
 - Develop plans as needed for demolition of the existing belt filter press and installation of new pads and supports as required.
- 4. Electrical Design Services shall be modified to include:
 - a. Develop plans and specifications as needed for demolition of the existing belt filter press and polymer feed system and electrical connection and SCADA control of the new units.
